

Terms of Service Agreement

1. ACCEPTANCE OF TERMS

Welcome to Retriever News/EntryExpress. Retriever News/EntryExpress provides its service to you, subject to the following Terms of Service ("TOS"), which may be updated by us from time to time. Pricing and Administrative Fees are subject to change without notice. You can review the most current version of the TOS at any time at: <http://www.entryexpress.net/tosfullscreen.aspx>. In addition, when using particular Retriever News/EntryExpress services, you and Retriever News/EntryExpress shall be subject to any posted guidelines or rules applicable to such services which may be posted from time to time. All such guidelines or rules (including but not limited to our [Spam Policy](#)) are hereby incorporated by reference into the TOS. Retriever News/EntryExpress may also offer other services that are governed by different Terms of Service.

2. DESCRIPTION OF SERVICE

Retriever News/EntryExpress currently provides users with access to a rich collection of resources, including various communications tools, search engines, printing services, and personalized content (the "Service"). You also understand and agree that the Service may include advertisements and that these advertisements are necessary for Retriever News/EntryExpress to provide the Service. You also understand and agree that the service may include certain communications from Retriever News/EntryExpress, such as service announcements, administrative messages and the Retriever News/EntryExpress Newsletter, and that these communications are considered part of Retriever News/EntryExpress membership and you will not be able to opt out of receiving them. 5. MEMBER ACCOUNT, PASSWORD AND SECURITY

You will receive a password and account designation upon completing the Service's registration process. You are responsible for maintaining the confidentiality of the password and account, and are fully responsible for all activities that occur under your password or account. You agree to (a) immediately notify Retriever News/EntryExpress of any unauthorized use of your password or account or any other breach of security, and (b) ensure that you exit from your account at the end of each session. Retriever News/EntryExpress cannot and will not be liable for any loss or damage arising from your failure to comply with this Section 5.

6. MEMBER CONDUCT

The laws of the State of Georgia shall apply to and control any interpretation, construction, performance or enforcement of these Terms and Conditions. The undersigned agrees that any litigation or collection actions prosecuted by EntryExpress collecting any sums due shall be heard by the Superior, State or Magistrate Court of Grady County, Georgia, as selected by EntryExpress, the undersigned herein submitting himself to the jurisdiction and acknowledging venue as being proper in said litigation.

24. Number

Whenever applicable within these Terms and Conditions, the singular shall include the plural and the plural shall include the singular.

25. Headings

The headings of paragraphs herein are included solely for convenience of reference and shall not control the meaning or interpretation of any of the provisions of these Terms and Conditions.

26. No Waiver

No failure to exercise and no delay in exercising any right, power or remedy under these Terms and Conditions shall impair any right, power or remedy which EntryExpress may have, nor shall any such delay be construed to be a waiver of any such rights, powers or remedies or an acquiescence in any breach or default under these Terms and Conditions, nor shall any waiver of any breach or default by EntryExpress be deemed a waiver thereof.

27. GENERAL INFORMATION

Entire Agreement. The TOS constitute the entire agreement between you and Retriever News/EntryExpress and

govern your use of the Service, superseding any prior agreements between you and Retriever News/EntryExpress. You also may be subject to additional terms and conditions that may apply when you use or purchase certain other Retriever News/EntryExpress services, affiliate services, third-party content or third-party software. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. **I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN TIS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.***

29. Non-EE Events

Entry Express and Retriever News are the exclusive, authorized recording, tracking and verification service for all event results specifically assigned by the appointed Secretary of each respective national club. Results recorded and tracked are associated with annual national championship and invitational events, annual and cumulative awards authorized or bestowed by the NRC, NARC and MARC. All of these events are sponsored by Retriever News. Retriever News has provided this service for over 50 years and now does so in exclusive coordination with Entry Express. For clubs that use the entry services of Entry Express, the results recording, verification and tracking is a free, automated process/service.

For clubs that choose not to use the entry services of EE for their events but wish to have the event results count toward the various national events and awards listed above, the event running orders must be entered into the EE database through the non-EE event portal provided through the EE website PRIOR to the event start date but after the running orders are set. The entry of the event running orders must be accomplished by a person authorized by the club as the club administrator on the EE website. This will ensure that event results will be counted and tracked related to dog and handler performance with associated points and passes recorded for annual and cumulative national achievement and qualifications. Running orders for ALL stakes and flights must be entered and affirmed as accurate to the running order documented in the event catalog.

The charges, for the use of the Entry Express software for the non-EE event accounting, recording and tracking service, will be \$4.50 (or a minimum of \$250) for each master dog entered into the Master stake(s) of each AKC hunting test event and each of the major stakes dogs of each AKC field trial event. Please note that ALL stakes – including senior and junior (hunting test) & derby and qualifying (field trials) - of the event must be entered for historical documentation of the event even though there is no charge associated with these minor stakes. Results for these events must then be entered within 48 hours of the event completion using the same entry portal process and the results affirmed by the event secretary (at no additional charge). If results are not entered as required, the results will not be counted. A catalog must also be provided directly to Retriever News for any event, which is verified and retained as a record of the event results.

Entered event results will then be recorded, verified and tracked for the national events of the NRC, NARC, MARC and any other awards tracked or awarded by Retriever News. This includes Purina Top Dog award and the National Derby List.

This recording, verification and tracking service is an automated free service provided to clubs that use the entry services of Entry Express.
